Terms of Contract

- 2. Guest(s) will vacate the premises upon expiration of this contract (reference check out time and date). Guest(s) waive ALL rights to process if they fail to vacate premises upon expiration of the accommodation period.
- 3. Guest(s) shall maintain the premises in a good, clean, and "ready to rent" condition, and use the property in a careful and lawful manner. Premises will be left in "ready to rent" condition upon departure at the expiration of the accommodation period. Guest(s) agree to be responsible for repair and/or maintenance costs should the property be left in lesser condition, i.e. "normal wear and tear."
- 4. Guest(s) shall not sublet the property.

- 7. Guest(s) expressly acknowledge and agree that this contract is for TRANSIENT OCCUPANCY of #5419 Ocean Lakes Campground. The Guest(s) CANNOT use this property as a long term residence.
- 8. There shall be NO refunds/reimbursement of rent in the event of shortened stays or ruined expectations due to weather conditions, work obligations, family emergencies or any other commitments or life events.
- 9. Note Hurricane Season is June 1 November 30th. If you are booking your stay with us within this time frame, guest(s) may want to consider purchasing vacation (travel)insurance in case of a hurricane or tropical storm.
- 10. Guest(s) shall use this property for legal purposes only. Guest(s) understand that use of illegal drugs, abuse of any person, harboring of fugitives, storing of stolen property, etc. shall cause immediate termination of this contract.

AGE CURFEW

Parking Fees

*** There is a **Zero Tolerance Golf Cart Policy** ***

The golf cart is complimentary, because you have personally assured me that you will follow all of the golf cart rules both implied by Ocean Lakes and by me as the owner of this accommodation. It should be further understood that if a golf cart infraction occurs while under the operation of any guest(s) you will lose your full security deposit, all paid accommodation amounts, and an additional \$1500 fine. You will be mandated to vacate the premises immediately. If infractions occur against our golf cart we (the owners), and all Guest(s) are at risk of losing the use of our golf cart for an entire year, and we will have to remove it from Ocean Lakes properties. Be aware that fines for breaking the rules can be up to \$1,500.00 fine

- Please diligently read our golf cart policy that will be in your rental when you arrive. Your signature confirms that all guests are informed on rules and regulations of golf carts. Ocean Lakes has strict golf cart rules, and they must always be followed.
- You must be 21 years of age, and have a valid driver's license in your possession to operate the golf cart. If someone in your group under the age of 21 wants to drive a golf cart they will have to rent one from Ocean Lakes.
- GOLF CART CURFEW: Ocean Lakes has a Midnight curfew for the operation of a Golf Car and other modes

- Quiet hours are 12am-5am, golf carts are not allowed to operate during these times
- Golf carts operating after sunset must have the lights turned on
- A maximum of 5 people on the golf is allowed at any given time
- Golf carts must be driven only on roadways, and are not permitted on the beach, within restricted areas or driven in vacant campsites.
- Playing of loud music is not tolerated by Ocean Lakes, playing any music that is vulgar is also not tolerated
- Do not leave children unattended on the golf cart
- Alcohol is not permitted on the golf cart in any type of container
- Reckless driving, horse play, racing or misuse of the golf cart is not permitted
- Obey all traffic signs within Ocean Lakes Campground
- UNDER NO CIRCUMSTANCES CAN AN UNDERAGED DRIVER DRIVE THE GOLF CART. If a child is in your lap YOU must have control of the golf cart with hands on the wheel.
- Never leave the key in the golf cart
