As of this contract the owner agrees to rent the property identified by Site MH502 during the specified dates above according to the following terms and conditions:

1. Check-in time is 3 p.m. and check-out time is 10 a.m. **Strictly enforced.**

Early arrival is not permitted. The front door of this house will be unlocked at 3 p.m. and the keys will be inside the house.

2. Security deposit against damages in the amount of \$500 is required in advance. Upon inspection of the premises, owner determines if the security deposit is to be refunded. **Refund will be mailed 14 days after check out to renter**, allowing me to receive any fines/notices from Ocean Lakes, if any have occurred.

3. Renter must be 25 years or older to occupy the premises throughout

the rental stay. The **maximum** number of persons permitted to occupy is **ten (10) and is strictly enforced**. The contract will be voided, and the renter(s) and guests of renter(s) will be asked to leave the premises (at any time) with no refund of rental money, including the deposit.

4. Renter is responsible for all damages that occur during the rental dates of this contract. The renter is encouraged to notify the owner of any visible damages upon arrival at the property. Take pictures and text them to me immediately.

5. If renter cancels more than 60 days prior to check-in date and the owner can re-rent the property, the deposit will be refunded minus a **\$100** cancellation fee. If the house remains vacant, you will forfeit your money. If renter cancels less than **30 days** from check-in date ALL money is forfeited.

6. The rental period may NOT be sub-leased, transferred, sold, or given to any other party. **The person signing the contract must not allow anyone underage to stay on this property without them being present.**

7. The owner may enter at any reasonable times, with or without notice, for the purpose of making repairs or inspections.

8. The owner shall NOT be responsible for any accidents or injuries occurring to the renter or guest of the renter on this property or premise.

9. The renter hereby **agrees to reimburse** the owner for any penalty that may be imposed upon the owner by any court by any reason of any violation upon the premises through fault of the renter herein his/her family members or guests.

10. The renter agrees to **NO HOUSE PARTIES or loud noises**. If Horry County police are called to this site for any disturbances, you will be fined **\$500 or more**.

11. Renter agrees to comply with all rules and regulations of Ocean Lakes Family Campground and the following or the rental

agreement:

- a. **NO SMOKING INSIDE THE HOUSE! (No vaping inside the house)**
- b. **Shooting fireworks on the property is prohibited and against the law.**
- c. Garbage- renter is asked to secure all garbage in plastic bag, place in

available trash cans for pickup. Trash pickup is Tuesday and Friday- they come inside the circle private drive to pick up trash. Do not place trash by the main road (leave them by the fence).

12. Owner is not responsible for damages resulting from hurricanes, tornados, floods, or other natural disasters. Renter is responsible for evacuation if deemed necessary with prorated refund given.

13. The house has been inspected before your arrival and should be clean and in order. Upon departure, each guest is responsible for cleaning and leaving the house in good condition. If the house is left unclean, or if there are any damages, money will be taken from your security deposit to cover expenses. If the cost of damages, cleaning, or golf cart violations exceeds the deposit the renter agrees to pay the difference immediately upon receipt of an invoice from the owner.

Inspect the house upon your arrival and report any concerns immediately.

14. After reading carefully, sign and return to address with the security deposit of \$500- YOU HAVE 10 days to get this back to me.

unless prior arrangements with me have been made. You will
need paper products such as tissue, paper towels, toilet paper.**

The kitchen is fully stocked with pots, pans, crockpot, towels, and potholders.

- **A full-size washer and dryer are available. The house has a dishwasher as well.**
- **A complimentary golf cart is available, and you must be 21 to drive. NO EXCEPTIONS.**
- **If Horry County Police is called to the house, you will receive a fine of at least \$500 from them and it could be more. YOU WILL LOSE your security deposit. Please do not do anything so the neighbors will call the police-it happens. IF you are asked to leave by Ocean Lakes/Horry County Police you will not be refunded any money.**
- **You must be 21 to drink and if anyone is caught underage drinking you will be kicked out by the owner and/or by Ocean Lakes. You will also be fined at least \$100. You will not be refunded any money and will lose your deposit.**
- **When you arrive, the house will be unlocked and/or in the lock box and keys will be on the counter. Walk through the house and make sure no damage is present and it is clean.**
- **When you leave, clean the house and leave it as you found it-also meaning do not rearrange the furniture, cookware, glasses, and dishes- lock the house and leave the keys on the counter or leave them under the doormat.**

“Please read ALL of your agreement before you sign it”

Our home is located inside Ocean Lakes Family Campground which means it is a FAMILY campground.

We want to ensure that there is not a breakdown in communication as to what is expected of you, your family, or group as guests in our home.

Ocean Lakes has new rules as of January 1, 2012 it is as follows:

If any guest, family, or friend using your unit is either **evicted and/or arrested** while on your property, the homeowners will be held responsible for that behavior and will be assessed an escalating fine for each incident. Our home **is not** a “party house.” Please remember you have neighbors and have respect for them. In saying this we do not allow underage drinking, drunkenness, weapons of any kind, loud and vulgar language, loud music, fighting, or arguments.

Fines are as follows:

1st incident-
\$500.00

2nd incident-
\$1000.00

3rd incident- loss of the right to rent for a minimum of 1 year

4th incident- possible to termination of lease

If any of this agreement is broken while you are a guest these “fines” will be passed on to you and by signing this agreement, you agree to pay all fines assessed because of your (family, friends) misbehavior during your stay. If court action is required to obtain fine payments, you also agree to pay all

court costs in addition to these fines.

These rules are put in place by Ocean Lakes and we must follow them if we want to continue having a home in Ocean Lakes. Please help us with making sure all your family members and guests know what is expected of them so Ocean Lakes remains the safest and most enjoyable family-oriented vacation destination we can possibly have.

**GOLF CART
RULES**

Here are the rules regarding the golf cart and if any of these are broken at any time during your rental period THE GOLF CART WILL BE TAKEN AWAY AND YOU WILL HAVE TO RENT ONE FROM OCEAN LAKES AT YOUR OWN EXPENSE.

- **No one under the age of 21 can drive or even sit behind the wheel of the golf cart. For example: sitting in the lap of someone that is 21 or older and driving the golf cart is not allowed. You must have a valid driver's license and be a renter of this house.**
- **Golf cart cannot be taken out of the gates of Ocean Lakes Family Campground. Ocean Lakes will fine you and you will lose the privilege of this cart.**
- **Ocean Lakes quiet time is 11 p.m. to 7 a.m. so the golf cart must be at the house during these hours.**
- **No reckless driving or horse playing on the golf cart-if you are seen doing so the golf cart will be taken away immediately.**

My property manager lives in Ocean Lakes the entire summer and I

have friends and neighbors that live here as well. They help me look after my property. The golf cart is a privilege and I am taking a high risk when I allow you to use it. This is what I worry with most, if an unlicensed driver gets caught using my cart, I will lose my golf cart rights/privileges and I will have to remove my golf cart from my site forever! This means I won't have a golf cart at my house for renters or personal use. If you have anyone under the AGE OF 21 WHOM WANT TO DRIVE A GOLF CART- RENT ONE FROM OCEAN LAKES. If an underage driver is caught I will receive a \$500 fine which you (the renter) will have to pay me if you are ticketed by Ocean Lakes for any violations on the golf cart and will also get a \$100 ticket from Ocean Lakes that you will have to pay them.

All privately owned golf carts can only be covered by homeowner's insurance and this insurance only covers the homeowner; therefore, renters are responsible for any injuries to people, property, or damages that may occur while using my golf carts.

I HAVE READ THE GOLF CART RULES AND WILL ABIDE BY THEM MY ENTIRE RENTAL PERIOD.

By signing below, you are agreeing to pay the \$500 fine to the homeowner if ticketed by Ocean Lakes for any violations and the \$100 ticket payable to Ocean Lakes. You also agree to pay for any costs or damages caused by the golf cart while renting the house.
