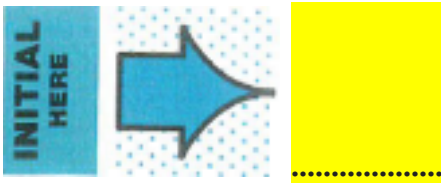

**Weekly Reservations:** Rental begins at 4:00 PM. Sunday and ends at 10:00 AM. the following Sunday. Any change from the Sunday-to-Sunday rental will be done on a case-by-case basis and only when schedule allows.

**Check-In/Check Out:** Check-in time is **4:00 p.m.** and check-out time is **10:00 a.m.** **THIS IS STRICTLY ENFORCED! EARLY ARRIVAL IS NOT PERMITTED.** Upon departure, please make sure all dishes, pots, pans and dish towels have been washed and put away. Also be sure that the refrigerator and freezer are empty. Beds need to be made with comforters and pillows being placed back on beds for the next guests the way you found it upon arrival. If you have purchased the Linen Package please place used towels in the shower stall. Sheets can remain on the bed.

The person signing this contract **MUST BE 25** years or older and occupy the premises throughout the entire stay! Renter must not allow anyone under the age of **25** to stay at the property without being present. The rental period may not be sub-leased, transferred, sold, or given to any other party or at any time.

**\*\*\*The maximum number of people permitted to occupy and sleep in this property is SIX (6) and need to be registered prior to check-in. THIS IS STRICTLY ENFORCED.\*\*\*** If any of the rules above are broken this contract will be voided, and the renter(s) and guest(s) of renter(s) will be asked to leave the premises (at any time) with **NO REFUND OF RENTAL MONEY INCLUDING THE SECURITY DEPOSIT.**

**Rental Unit:** Unit is completely furnished with limited supplies including: paper towels, toilet paper, soap, washing detergent, trash bags. Please bring your own bath towels and bed linens. Beds and furniture are NOT to be moved from room to room. Rental has 2 queen beds & 1 full over twin bunk bed. **\*\*\*DO NOT TAKE QUILTS ON BEDS OUTSIDE THE HOME.\*\*\***

**Security Damage Deposit:** This deposit of **\$500** is required in advance with a signed contract for your week to be held. This may be paid by check, Zelle, Venmo or Square. The renter is responsible for any and all damages that occur during the rental dates of this contract. The renter is encouraged to notify the owner of any visible damages upon arrival.

\*\*\*All objects inside and outside the house including decoration are itemized and must not be taken by the guests at any time/check out.\*\*\* Upon inspection of the premises and notification from Ocean Lakes that there has not been any fines assessed on the property, the owner determines if the security deposit is to be refunded. Refund due will be mailed to renter within 14 days of departure. This gives us time to receive notices/fines from Ocean Lakes if any have occurred. If cost of damages, cleaning costs (beyond basic that is already covered) exceeds the deposit, **the renter agrees to pay the difference immediately upon receipt of an invoice from the owner.**

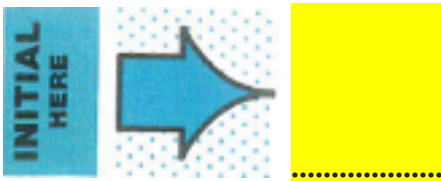
**Golf Cart:** We offer a golf cart for a \$450 fee. We require a **\$500** refundable security deposit. In order to operate the golf cart, you must be **25 YEARS OLD** or **OLDER** with a valid driver's license per our insurance and has to be registered prior to check-in. **\*\*\*THIS IS STRICTLY ENFORCED.\*\*\*** The property owner reserves the right to suspend cart privileges at any time and keep the golf cart security deposit. **Please see attached Golf Cart Policy Agreement.** If you are stopped and issued a ticket **YOU will be responsible to pay the fine and also the fine that is given to us as the owners.** Upon inspection of the cart and notification from Ocean Lakes that there have not been any violations/fines assessed the deposit will be mailed to renter within 14 days of departure. **\*\*\*If preferred, Ocean Lakes provides golf cart rentals for 16 years old and up with a valid driver's license.\*\*\***

**Cleaning:** The \$150 covers basic cleaning; any additional cleaning fees will be deducted from the Security Deposit.

**Linen Package:** The **optional** \$125 Linen Package includes sheets for all of the beds, 6 bath towels, 6 wash clothes, 6 face towels and 2 bath mats.

**Cancellation Policy:** If the renter cancels more than 45 days prior to check-in date there will be a 10% penalty fee of the gross amount of the rental. The security deposit will be refunded in full. If the renter cancels less than 45 days prior to check-in date, the amount paid will not be refunded. The security deposit will be refunded in full.

**Parking Restrictions:** Parking is limited to **TWO** cars and **ONE** golf cart. A parking pass is required by OCEAN LAKES. Once we receive the signed rental agreement with payment, we will inform Ocean Lakes that you will be a guest at V-25 during your stay. Ocean Lakes will e-mail you a secure payment link with your authorization number. If you need additional parking, you can inquire with Ocean Lakes for the overflow parking.

**Pet Policy:** **NO** pets are allowed at any time. **If you bring a pet, this rental agreement will be forfeited, terminated and deposits will be retained, and deep cleaning fees will be applied.**

**Smoking:** **NO SMOKING/VAPING INSIDE OR ON THE PREMISE.** If caught violating these, this contract will be voided, and the renter(s) and guest(s) of renter(s) will be asked to leave the premises (at any time) with **NO REFUND OF RENTAL MONEY INCLUDING SECURITY DEPOSIT.**

**Security Cameras:** Renters understand and accept that the property is protected with outside security cameras. These cameras are used to protect the property from potential break-ins and theft. There are **NO** cameras inside the house.

**Maintenance:** We will make every reasonable effort to have the repairs made as soon as possible. Under no circumstances will any refunds be made for mechanical failure of dishwasher, TV, washer/dryer, or other small appliances. All service requests will be handled within a 24-hour period. The owner may enter the premises at reasonable times, with or without notice, for the purpose of making repairs or inspections.

**Accidents/Injuries:** The owner shall NOT be responsible for any accidents or injuries occurring to the renter or guests of the renter on this property or premise.

**Garbage:** Renter is asked to secure all garbage in a plastic bag and place it in available containers for pickup and container be pushed to the edge of the road.

**Fireworks:** No fireworks of any kind are permitted in Ocean Lakes Family Campground.

**Hurricanes and Tropical Storms:** Owner is not responsible for damage resulting from natural disasters. Renter is responsible for evacuation if deemed necessary with prorated refund given.

The premises have been inspected before your arrival and will be clean. Upon departure, guests are responsible for texting the owner at **704-458-0342 or 704-560-4221** letting them know the property is vacant and the cleaning company can come in to inspect the house. Any missing items, or if damage is done to the house, or if the house is left unclean beyond reasonable standards, money will be taken from the security deposit to cover expenses. If cost of missing items, damages, cleaning costs, violations, or golf cart damages exceeds the deposit, **RENTER AGREES TO PAY THE DIFFERENCE IMMEDIATELY UPON RECEIPT OF AN INVOICE FROM THE OWNER.**

Renter agrees to comply with all the rules and regulations of Ocean Lakes Campground and the rental premises. **\*\*\*NO HOUSE PARTIES or LOUD NOISES. QUIET TIME is 11 p.m. to 7 a.m.\*\*\* Please see attached policy.** If Horry County police are called to this site for any disturbances, you will be fined \$500 or more. The renter hereby agrees to reimburse the owner for any penalty that may be imposed upon the owner by any court by any reason of any violation upon the premise through fault of the renter(s) herein his/her family members or guest(s).

### **PLEASE READ ALL OF YOUR AGREEMENT BEFORE SIGNING**

- Our home is located inside Ocean Lakes Family Campground which means it is a **FAMILY** campground.
- We want to ensure that there is no breakdown in communication as to what is expected of you and your family and guest(s) in our home.
- Ocean Lakes has implemented a new procedure which is stated as followed:  
If any guest(s), family or friend using your unit is either **evicted** or **arrested** while on your property, the homeowner will be held responsible for that behavior and will be assessed an escalating fine for each incident.
- Our home is **NOT** a party house. Please remember you have neighbors and respect them. In saying this we do not allow drunkenness, loud and vulgar language, or music, fighting or arguments in our home or home premises.

#### The new procedure will be as follows:

1<sup>st</sup> incident \$500 fine

2<sup>nd</sup> incident \$1,000 fine

3<sup>rd</sup> incident \$1500 fine and loss of right to rent for a minimum of 1 year

4<sup>th</sup> incident, possible termination of lease.

- If the above is not followed while you are a guest these fines **WILL BE PASSED ON TO YOU** and by signing this agreement **YOU AGREE TO PAY ALL FINES ASSESSED** because of the misbehavior during your stay. If court action is required to obtain fine payments, you also agree to pay all court costs in addition to these fines.
- If misbehavior is reported to owner, owner has the right to void this contract and the renter(s) and guest(s) of renter(s) will be asked to leave the premises (at any time) with **NO REFUND OF RENTAL MONEY INCLUDING SECURITY DEPOSIT.**
- These rules are put in place by Ocean Lakes Family Campground, and we must follow them if we want to continue to have a home here. **GOLF CART POLICY:** We offer an **optional** golf cart to approved renters. A **\$500 refundable deposit** will be required for use of the golf cart. Driver license number (s) will be required.

- **V-25 "Ke Aloha Kai"** requires **ALL** cart operators to be **REGISTERED GUESTS AND 25 YEARS OLD OR OLDER** with a valid driver's license. **\*\*\*THIS IS STRICTLY ENFORCED.\*\*\*** If this is violated the property owner reserves the right to suspend cart privileges at any time and keep the golf cart security deposit of \$500.
- Cart rental fees are non-refundable if suspension or breakdown occurs.
- The property owner shall not be held liable for any injuries to cart occupants.
- Golf cart capacity can't exceed 5 people.
- Ocean Lakes Family Campground has a **ZERO TOLERANCE POLICY** for violations of golf cart rules. If you are stopped and issued a ticket **YOU will be responsible to pay the fine and also the fine that is given to us as the owners.**
- **NO** carts are to be out during quiet time **11 pm – 7 am**. If misbehavior is reported to the owner, owner has the right to void this contract and the renter(s) and guest(s) of renter(s) will be asked to leave the premises (at any time) with **NO REFUND OF RENTAL MONEY. Please see attached Page # 6.**
