- Our house is in Ocean Lakes Family Campground (6001 S. Kings Highway), approximately 4 miles south of Myrtle Beach, SC, on US Highway 17.

- 2. Our house is a single-family dwelling and Ocean Lakes is a family-oriented environment. This agreement allows for a maximum of eight (7) people to occupy our home. You must be at least 25 years old to rent our house. If you rent our house, you must also be present in the house during the ENTIRE rental period if you are responsible for supervising anyone that accompanies you who is under the age of 25.
- 3. A car pass is needed for entry into the property, which has 24 hr. security. There is an \$12.00 per night, per car, visitor fee. A letter will be mailed/emailed to you to take to the rental office upon arrival to obtain your car pass, or you can mail it into Ocean Lakes Campground (6001 S. Kings Highway, Myrtle Beach, SC 29575) with your check and receive your car passes through the mail. We highly recommend that you mail-in for car passes as check-in can be very crowded on Saturdays!

- 4. We're sorry, but we do not allow pets of ANY kind in our house or on our property.
- 5. The house has a keyless entry, and a code will be provided to you, all other necessary keys will be on the hook in the livingroom.
- 6. No fireworks of any kind are permitted on Ocean Lakes Family Campground property.
- 7. No smoking (including Vaping) is allowed in our house.
- 8. Motorcycles cannot be ridden on Ocean Lakes Family Campground property. They can enter the property on a trailer, can be walked to our house, or can be parked in the Ocean Lakes designated area.

- 9. Ocean Lakes Family Campground strives to maintain a wholesome family-oriented environment. If your conduct disturbs or offends other guests or residents, within reason, Ocean Lakes Security will escort you off the property and we will not refund any part of your rent.
- 10. Our house has 3 bedrooms and 2 bathrooms. It is fully furnished including 1 King Bed (Rm. 1), 1 Queen Bed (Rm. 2), and 1 single over double Bunk (Rm. 3). Color TV with extended cable and WiFi are provided.
- 11. Our house is equipped with a coffee pot, dishwasher, crockpot, pots and pans, Tupperware, silverware/dinnerware, gas grill (if the tank is out of gas, you will need to refill them at the campground store at your expense).
- 12. There is NO telephone in our house.
- 13. You need to bring:
- a. Linens: sheets, pillowcases, extra blankets
- b. Towels: bathroom towels, wash clothes, kitchen towels, beach towels
- c. Paper products: toilet paper, paper towels
- d. Soap, washing detergents, trash bags
- 14. A **reservation deposit** of \$300.00 is due when you make your reservation official by signing and returning this agreement. This deposit will be applied to your rental agreement balance. An additional \$300 is also due upon signing of this agreement and will be held as your **security deposit**. Your security deposit will be held until departure and cleaning crew confirms no damages to the house. Once confirmed, your deposit will be returned to you within two weeks of your departure date. Please note that your reservation includes a \$125 mandatory cleaning fee.

We accept checks and money orders. If your check is returned to us by the bank, we will charge you \$50. In the event you are unable to keep your reservation, we will refund both your rental and security deposits provided a 30 day notice PRIOR to your arrival date.

- 18. Check in time is 4:00pm. Check out time is 10:00am. If the house becomes available earlier than 4:00pm, you will be contacted.
- 19. When you arrive at our house, please check that the prior renter did not leave dirt or damage. In order to protect YOUR security deposit, please report problems immediately (by 10am of the
